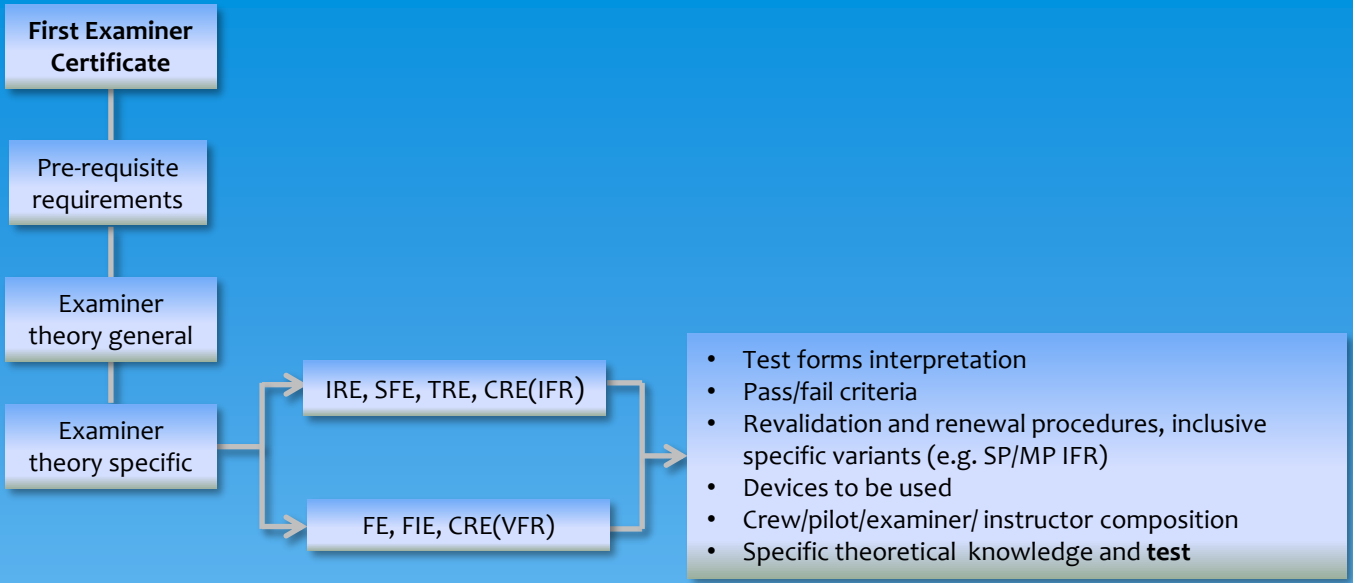

- This test will be a realistic scenario including briefing, conduct of the test, debriefing and all the documentation tasks.
- The inspector will decide if required standard has been achieved or if further training and another progress test is required.

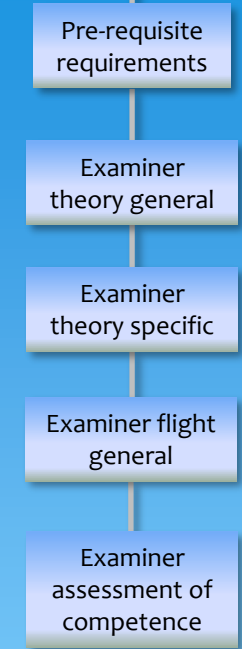
### Revalidation Examiner Certificate Single Pilot



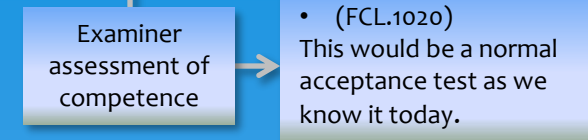
