- (9) legal aspects and enforcement procedures;
- (10) navigational skills including new or current radio navigation aids;
- (11) teaching instrument flying;
- (12) weather-related topics including methods of distribution;
- (13) any additional topic selected by the competent authority.

- (4) observational skills;
- (5) instructional techniques;
- (6) briefing and debriefing skills;
- (7) TEM;
- (8) human performance and limitations;
- (9) flight safety, prevention of incidents and accidents, including those specific to the ATO;
- (10) significant changes in the content of the relevant part of the aviation system;
- (11) legal aspects and enforcement procedures;
- (12) developments in competency-based instruction;
- (13) report writing; and
- (14) any additional topics proposed by the competent authority.
